**ORDER**

Whereas, it has been made to appear to me that prices of various Ghee/Oil Brands have registered uncalled for an abnormal increase recently and there is likelihood of further increase in the prices of the same.

And whereas, it has become necessary and expedient to make an order to maintain supply of various Ghee/Oil Brands for securing equitable distribution and availability of Ghee/Oil Brands at controlled/reasonable price in the public interest.

And whereas in supersession of all previous notifications issued and in pursuance of Notification issued by Govt. of the Punjab, Industries, Commerce and Investment Department vide No.SO(R)2-2/2015, dated 02.04.2015, I, Syed Najaf Iqbal, District Coordination Officer, Narowal do hereby revise and re-fix the prices of under mentioned Ghee/Oil Brands as indicated against each within the revenue limits of Narowal District.

No person/shop keeper shall charge or cause to be charged the prices of the above mentioned Ghee/Oil Brands in excess of those fixed above or refuse to sell the same at the fixed prices. Every person engaged in the dealing of the above commodities shall have a notice board/price list displayed on a conspicuous place of his premises/establishment/shop showing the above fixed rates.

This order shall come into force with immediate effect and shall remain in force within the revenue limits of Narowal District till it is withdrawn, modified or rescinded. It shall be given wide publicity in the local News Papers and by affixing copies thereof at notice board at the District Coordination Officer, District Officer (Coord), all Assistant Commissioners, District Officer (E&IP), all Tehsildars and also offices of District Police Officer, sub-Divisional Police Officers and all Police Stations in the District.

Any contravention of this order shall be punishable under the relevant provisions of law.
